JOB PURPOSE

The provision of Air Platform Protection (APP) advice, through threat vulnerability assessment and countermeasures development to the APPTES customer on the customer site.

KEY DUTIES AND RESPONSIBILITIES

- To provide advice, as required and requested by the customer on any threat systems within your sphere of experience.
- Where requirements are outside your experience, to investigate requirements such that you are better able to provide the required level of advice.
- To assist in the planning, execution and analysis of Electronic Warfare trials as required.
- To be available to support UK or overseas trials for up to 6 weeks duration at a time, to an annual limit of 10 weeks per annum.
- To support meetings anywhere in the UK, as required and directed by the customer.
- To maintain a professional level of understanding of either RF or IR theory and operation of relevant systems as required and directed by the Lead TVA.
- To develop and maintain an expert understanding of the following general systems: Missile Warning Systems, Radar Warning Receivers, Electronic Support Measures, Electronic Countermeasures, Directed IR Countermeasures, Countermeasure Dispensing Systems, RF and IR Expendable Decoys and any other systems that may, from time to time, become appropriate to the role.
- To carry out countermeasures development in accordance with locally accepted procedures.
- To maintain the required level of understanding of and ability to program in MATLAB, as required and directed by the Lead TVA.
- To maintain the ability to be able to analyse large and complex data sets from multiple sources.
- To produce and deliver reports and briefs to technical and non-technical customers as required and directed by the Lead TVA.
- To provide coherent and consistent support and advice to the customer by maintaining effective communications and working practices within the team.
- To be prepared to work in adverse conditions when the situation warrants in support of customer trials activities.
- To work under your own initiative whilst keeping the Lead Analyst informed of direction, key

conclusions and decision points.

- To ensure that the Lead TVA is aware of your expected location during working hours.
- To maintain appropriate UK security clearances.
- To maintain a full UK driving licence.
- Comply with Company policies and procedures
- · Adhere to the MASS values.
